From the President

From the president: These comments are in two main parts, but first an overture.

Overture

The qualitative researcher, like the field of qualitative inquiry, refuses to be frozen into one space, or one fixed identity. We are constantly changing, creating new identities, new ways of being, transforming, shedding one skin after another, staying alive, giving up control, taking chances, seeking emotional truth, listening to multiple voices, experimenting with mirrors, refraction, distortion. It is said of great artists that they show popular culture how to come to them. They raise the bar high and challenge others to rise to their level. Qualitative researchers must resist the temptation to bend to popular methodological or ideological demand. We must keep our own bar high, and ask others come to us, on our terms, not theirs. We will maintain our power and influence to the extent that we can do this, that is make the world bend to our vision (Sullivan, 2007, p. 84).

Confrences and Workshops

CFP: The Fourth International Congress of Qualitative Inquiry Ethics, Evidence and Social Justice

The Fourth International Congress of Qualitative Inquiry will take place at the University of Illinois at Urbana-Champaign from May 14-18, 2008. The theme of the Congress, building on previous Congresses, is "Ethics, Evidence and Social Justice." The Fourth Congress will offer the international community of qualitative research scholars the opportunity to engage in debate on ethical, epistemological, methodological and social justice issues. In these changing times, there are attempts to impose uniform bio-medical ethical standards on qualitative research. There are also increasing efforts to judge qualitative research in terms of experimental, or so-called scientifically based criteria. The politics of evidence and ethics carries important implications for how qualitative research is used in the pursuit of social justice issues. Participants will explore the relationship between these three terms and what these relationships mean for qualitative inquiry in this new century. If we as qualitative researchers do not take control of these terms for ourselves, someone else will.

Delegates will consider what ethics, evidence and social justice mean under the terms of postpositivism, poststructualism, indigenous, democratic, postcolonial, queer, feminist, performative, and participatory models of inquiry. Participants will explore new ways of evaluating and using qualitative evidence in social policy arenas.

Sessions will once again address such topics alternative models of social justice (western, non-western, indigenous, moral, ethical, scientific, critical, reconciliation); the politics of evidence; interpretive criteria for evaluating qualitative inquiry; qualitative alternatives to evidence-based models; mixed-method inquiries; case studies and public policy discourse; different models of social justice; ethical regulatory systems (IRBs) and human subject research; indigenous research ethics; new ways of decolonizing inquiry; race, class, gender and standpoint epistemologies.

Contributors are invited to experiment with new methodologies and new presentational formats (drama, performance, poetry, autoethnography, fiction) while presenting the results of inquiries that implement these methodological innovations. Sessions will offers scholars the opportunity to demonstrate the importance, value, and relevance of qualitative inquiry in these troubling global times. Such work will offer guidelines and exemplars of how qualitative research can be used in the policy-making arenas.

On May 13 there will be preconference language events and on May 14, morning and afternoon professional workshops. The Congress will consist of keynote, plenary, featured, regular, and poster sessions. There will be an opening reception and barbeque as well as a closing old fashioned Midwest cook-out.

We invite your submission of paper, poster and session proposals. Submissions will be accepted online only from October 1 until December 1 2007. Conference and workshop registration will begin December 1, 2007. To learn more, please visit our Web site at www.icqi.org.

ICQI Announces Call for Nominations: The Illinois Qualitative Dissertation Award

The International Center for Qualitative Inquiry is pleased to announce the third annual Illinois Qualitative Dissertation Award, for excellence in qualitative research in a doctoral dissertation. Eligible dissertations will use and advance qualitative methods to investigate any topic. Applications for the award will be judged by the following criteria: clarity of writing; willingness to experiment with new and traditional writing forms; advocacy, promotion, development, and use of qualitative research methodologies and practices in new fields of study, and in policy arenas involving issues of social justice. There are two award categories. Submissions in Category A use traditional qualitative research and writing forms, while Category B submissions experiment with traditional writing and representational forms

An award of USD \$250 plus a book credit of USD \$150, courtesy of Sage Publications, will be given to each winner. Eligible dissertation must be completed, defended and deposited within THREE years prior to (April 1, 2008). CALL FOR ESSAYS ON "EMERGENT INDIGENEITIES"

In spring 2007, the Board of the Society for Cultural Anthropology deliberated signing a letter drafted by the American Anthropological Association to be sent to the United Nations advocating passage of the Draft Declaration on the Rights of Indigenous Peoples. The letter generated intense discussion because of recognition among Board members that indigenous and minority status is configured very differently in different regions of the world, such that policies and programs addressed to "indigenous rights" have varied effects, and sometimes occlude critical political dynamics. The SCA decided to sign the letter, eager to support the gains some groups have achieved within the rubric of "indigenous rights." The Board also agreed that the Society's journal, Cultural Anthropology, could play a role in drawing out differences among indigenous groups, and how the rubric of indigenous rights can circumscribe political attention, entitlements and cultural production.

We hope to receive essays that address various regions of the world, and various dynamics through which indigenous and minority status is produced and plays out. Critical, from our perspective, is attention to the way indigenous and minority status is what Michael Fischer terms an "emergent form of life" - produced through complex social, cultural and political economic interactions, likely requiring reconsideration of conventional ways of thinking about politics, geography, sovereignty, rights, and other core categories. We also would like essays that highlight the double binds that emerge in efforts to deal well with indigenous and minority issues within established political, legal and cultural frameworks. In other words, we are interested in essays that examine how the politics of indigeneity can operate as what Stuart Hall famously called a "politics without guarantee" - attuned to the many ways mechanisms of liberations are entangled with what they critique.

The Iowa Journal of Communication announces a special 2008 issue on autoethnography. Manuscripts should be received no later than February 1, 2008.

At the end of Writing the New Ethnography, Goodall (2000) calls on ethnographers to fully engage "a dialogic ethic and a transformational vision" aimed at "evolving to a higher state of scholarly consciousness" (p. 198). In *The Ethnographic I* Carolyn Ellis (2004) defines autoethnography as "research, writing, story, and method that connect the autobiographical and personal to the cultural, social, and political" (p. xix).

Good autoethnographic writing engages the "ethnographic I" and works its transformational magic upon the researcher, the subjects of the research, and the readers who engage the work. This special issue will feature the best of current autoethnographic writing--writing that pushes the boundaries of scholarship, that seeks to engage the reader in a transformational journey, that shows a reflexive "ethnographic I", that develops the theme of a dialogic ethic, and that evokes the emotional-mental-physical-spiritual experience of human communicative life in various contexts.

We welcome submissions from researchers in a variety of areas, and from any perspective. We are particularly interested in new and experimental forms of evocative autoethnographic writing. Submissions from graduate and undergraduate students are invited for a special section of the journal. Any manuscript not accepted for the special issue will be considered for the general issue of the journal. The IJC follows a policy of blind review, so no author identification should appear in the body of the manuscript. Manuscripts should not exceed 25 pages and should include a title page that lists the author(s) name, academic position, institutional affiliation, full address, telephone number, and email information. A brief author bio should also be included. An abstract of not more than 100 words should accompany the paper. All submissions must conform to the most current edition of the APA Publication Manual. in policy arenas, as well as clarity of writing and willingness to experiment with new and traditional forms of presentation.

Linked to the annual Congress for Qualitative Inquiry, much of the journal's content will be drawn from presentations and themes developed from these international meetings. Attendees of the 2008 Congress will receive an annual subscription as part of their registration fees. Left Coast Press is also publishing an annual volume based on plenary and keynote addresses from each Congress. Previous volumes include Qualitative Inquiry and the Conservative Challenge (2006), and Ethical Futures in Qualitative Research (2007). Attendees at the 2008 Congress will receive a copy of the third volume in the series, Qualitative Inquiry and the Politics of Evidence (2008).

PART TWO

Work is well underway for the Fourth International Congress of Qualitative Inquiry (QI2008) to be held on the University of Illinois campus, May 14-17 2008. We expect the attendance of more than 1200 delegates from more than 60 nations and 30 disciplines. A full compliment of pre-conference sessions is being planned, including at least three Language Event Days (A Day in Japanese, a Day in Spanish, and a Day in Turkish), A Technology Day, and a Day for Nurses who do Qualitative Research. This year the Congress, as it did in 2007, will co-host the Annual Couch-Stone Spring Symposium of the Society for the Study of Symbolic Interaction.

The 2008 Congress has several new and returning co-sponsors, including Women and Gender in Global Perspectives (UIUC), the Program in Global Studies (UIUC), Sage Publications, Left Coast Press, The Society for the Study of Symbolic Interaction, and the Manchester Discourse Power Group (DPR).

There will be more than 20 pre-conference workshops. Over 850 papers will be presented and performed in 185 sessions. Keynote addresses will be given at the opening session of the Congress by Gloria Ladson-Billings and Ian Stronach. The winners of the Illinois Distinguished Qualitative Dissertation Award will be announced, with the winners receiving \$250 book certificates from Sage Publications.

The theme of the Fourth International Congress, "Ethics, evidence and Social Justice" builds on and extended the themes of the First, Second and Third International Congresses which focused on "Qualitative Inquiry in a Time of Global Uncertainty," "Ethics, Politics and Human Subject Research," and Qualitative Inquiry and the Politics of Evidence. Within the last decade resistance to qualitative inquiry has increased. Much of this resistance grows out of neoconservative discourses which assert that qualitative research is non-scientific, should not receive federal funds, and is of little value in the social policy, social justice arenas.

The International Association of Qualitative Inquiry (IAQI) was launched in 2005 at the First Congress. Three years later this new umbrella association has a Newsletter, and over 1500 members. IAQI and IIQI are currently active in establishing mutually beneficial relationships with existing national qualitative research associations in, among other countries, Argentina, Australia, Brazil, Canada, Colombia, Denmark, Finland, France, Germany, Great Britain, Ireland, Israel, Italy, Malaysia, Mexico, South Africa, South Korea, and Spain.

The IAQI Newsletter is a place to extend conversations about the association. We invite your contribution. The Newsletter offers a venue for taking up controversial topics. It is a site where new publications and up-coming conferences can be announced. Negotiations are under way to secure reduced subscription rates for IAQI members for a number of qualitative research journals. Please send us your announcements.
