From the Director

[Open Letter to Members of the Israeli Council of Higher Education]

Re: Grave Concern Regarding Attack on Academic Freedom in Israel

Dear Members of Israeli Council of Higher Education:

I am writing to express my grave concern about reported moves to close the Department of Politics and Government at Ben-Gurion University on the basis of the use of its faculty of apparently qualitative, non-positivist, research methods.

As the Director of the International Congress of Qualitative Inquiry I find this attack very worrying. Since the 1980's qualitative inquiry has become a cornerstone in the social sciences including in the discipline of political science.

I am alarmed by this incident, and the impact it has on academic freedom at a leading Israeli university. This may be the beginning of a slippery slope, leading to academic decline, and loss of academic contacts for Israeli academia.

Further, Israel's reputation as a center of academic freedom and excellence will be severely damaged. Critical scholarship is at the heart of academia in democratic countries, and should be protected and nourished.

I call on you to do everything you can to prevent the closure of this department, and to make every effort in your current capacity to protect the most important values of academic freedom and excellence.

We can make a difference; we can affect quality of people's lives. If we reach them.

Freeing Ourselves

Russell Bishop, University of Waikato Hamilton, New Zealand.

In this talk I intend detailing the development of an indigenous response to neo-colonial dominance in research, classrooms, schools and education systems. This talk will detail the journey over time that has led me from researching the impact of colonization on my mother's Maori family to an appreciation of just what researching in Maori contexts involves. The lessons learnt here also appealed to me, as an ex-secondary school teacher, as being a means by which the marginalization of Maori students in mainstream classrooms could be re-theorised. From this understanding was a means whereby educators could reposition themselves discursively and createcaring and learning relationships within mainstream classrooms that would see Maori students benefitting from their participation in education. From these theoretical beginnings grew a large-scale classroom-based project that eventually developed into a comprehensive approach towards theory or principle-based education reform that is now being implemented, in two different forms, in 150 secondary schools in New Zealand.

Fundamental to this theorising and practice were the un-

derstandings promoted by Paulo Freire over forty years ago, that the answers to the conditions that oppressed peoples found themselves in was not to be found in the language or epistemologies of the oppressors, but rather in that of the oppressed. This realisation was confirmed when I understood that researching in Maori contexts needed to be conducted dialogically within the world view and understandings of the people with whom I was working. This realisation also led me to understand how dialogue in its widest sense is crucial for developing a means whereby Maori students would be able to participate successfully in education.

Qualitative Book Award: Call for Nominations

The call for nominations for the 2013 qualitative book award: This award will be conferred annually to a member of the qualitative and ethnographic community who has published the English-language book that best represents an important contribution to qualitative inquiry. This year ICQI is dedicating the 2013 qualitative book award to the memory of H. L. (Bud) Goodall, a charter member of the awards committee judges.

Eligible books should not be edited books, or anthologies. They should be single or co-authored. They will use and advance qualitative methods to investigate any topic or aspect of qualitative inquiry and may involve research reports, interpretations, and analyses. Applications for the award will be judged by criteria that signify a major contribution to the study and practice of qualitative approaches. Such criteria may include success in experimenting with new or traditional writing forms, inclusion of critical reflections on the writing and research process, contributions to living meaningful lives, and insights into creating a socially just world. The award will be presented at the annual meeting of the International Congress of Qualitative Inquiry in May 2013.

To be eligible for the 2013 award, the book should have a publication date between 2011 and 2013. Nominators are expected to arrange for copies of the book to be mailed, on request, to the three-judge panel.

H.L. "Bud" Goodall, Jr.

H.L. "Bud" Goodall, Jr. passed away on August 24, 2012 at age 59 after a 15-month battle with pancreatic cancer. Bud was a professor of communication at Arizona State University and a celebrated qualitative scholar who published several books, including the award-winning ethnographic memoir, A Need to Know: The Clandestine History of a CIA Family (2006, Left Coast Press) and Writing Qualitative Inquiry: Self, Stories, and Academic Life (2008, Left Coast Press). A yearly award in his honor, titled the "The Bud: The H.L. Goodall, Jr. Annual Award for Narrative Ethnography," will be made collaboratively through the initiative for Innovative Inquiry at Arizona State University and the Ethnography Division of the National Communication Association, and it will be announced each year at the International Congress for Qualitative Inquiry. Funds for the award are being raised through sales of the festschrift volume, Celebrating Bud and a special fundraising drive by Innovative Inquiry. Indigenous Qualitative Inquiry Pre-Conference Day May 16th, 2012

"As a site of struggle research has a significance for indigenous peoples that is embedded in our history under the gaze of Western Imperialism and Western Science. It is framed by our attempts to escape the penetration and surveillance of that gaze whilst simultaneously reordering and reconstituting ourselves as indigenous human beings in a state of ongoing crisis" (Linda Tuhiwai Smith, Decolonizing Methodologies: Research and Indigenous Peoples, University of Otago Press, 1999, p. 39).

We held our first Indigenous Qualitative Inquiry (IQI) Pre-Conference Day at this year's congress after a year of organizational meetings across countries, time zones, academic disciplines, and identity politics—with a little help from our friend, Skype. This first gathering was the culmination of two years of grassroots planning that grew into a vibrant and cooperative group of 14 organizing members, several subcommittees, 8 panel sessions of varying formats in the regular congress, indigenous musicians and storytellers, and scholars (indigenous, betweeners, and allies) from New Zealand, Canada, USA, Brazil, Chile, and Australia.

We started with a Pre-Conference Day, or afternoon to be more precise, on the Wednesday before the official beginning of the ICQI 2012, with a warm welcome from Jamie Singson, Director the Native American House at the University of Illinois Urbana-Champaign. After a few remarks from the UIUC Provost about the importance of strengthening the connections between Western academia and indigenous peoples as we work together toward healing, we were honored by an opening ceremony led by Dr. Dorene P. Wiese, President of the American Indian Association of Illinois (AIAI). Dr. Wiese spoke of the history of the land the University of Illinois Urbana-Champaign now occupies. She gave us a brief and informative history of the colonization of the land and subsequent displacement of indigenous peoples who lived in Illinois before the arrival of European settlers. A Drum Group from the AIAI played traditional American Indian songs to wish us well on this journey of healing. We are grateful for their generosity of time, travel, and spirit.

The IQI afternoon continued with a filmed interview by Charlene Teters about the colonizing history of the Chief Illiniwek, a fictive figure invented by European settlers and used as UIUC's sports mascot since 1926 (The history of Teters' work is the subject of a nationally aired award-winning documentary In Whose Honor? by Jay Rosenstein). A brief conversation on the current situation about the now (reluctantly) retired mascot followed. Given the large number of attendees, Jamie Singson and Dr. Shauneen Pete, another one of our esteemed keynote speakers, organized our group into a large circle for the discussion of indigeneity and its decolonizing implications for ways of knowing and producing knowledge in the Academy. Over 40 people formed the large circle and each person got a chance to speak of their connections with indigeneity and struggles with decolonization. We then ended with a closing ceremony led by Joseph Naytowhow, Cree Knowledge Keeper & Storyteller, and member of the Pakitahaw Sahgaehican/Sturgeon Lake First Nation in Saskatchewan. A delicious meal in good company closed the IQI Circle for the day.

We reconvened at the start of the regular congress on Friday morning, with six panels on IQI throughout the day. Two more panels took place on Saturday morning. Despite some miscommunication in the preparation of the official program, and a few unfortunate mistakes in the time and place of a handful of presentations, we all agreed that the first IQI Circle (Pre-Conference Day and Friday/Saturday sessions) was a very positive beginning. In addition to learning about each others' research on indigeneity, we have also made concrete steps to strengthen our collaborative work. A special issue on Indigenous Qualitative Inquiries, to appear in the International Review of Qualitative Research and guided by several members of our circle (Craig A. Campbell, Buffalo State College, SUNY, USA; H. Monty Montgomery, University of Regina-Saskatoon, Canada; and Heather Ritenburg, University of Regina, Canada), is well under way.

We have already started preparations for the next congress in May of 2013. Once again, we will hold a Pre-Conference afternoon on the Wednesday before the start of the ICQI 2013 and Friday/Saturday sessions of a variety of formats (traditional, performative, collaborative, etc.). We are looking forward to continuing our work to expand the IQI Circle in years to come. May our paths cross soon.
