From the Director

Over 1200 international delegates from 65 nations attended the 4th International Congress of Qualitative Inquiry. Held on the dates of May 14-17, 2008, the Congress was co-sponsored by the College of Media, the Institute of Communications Research, the Department of Advertising, 10 local campus units, and 12 external sponsors. There were 22 pre-conference works, on various approaches to qualitative research. More than 950 papers were presented in over 190 sessions. Three all-day Pre-Congress Sessions-- A Day in Spanish, A Day in Technology in Qualitative Research, and A Day in Qualitative Inquiry in Healthcare-- were held on May 14. A Day in Turkish was held on May 17. The 2008 Congress was honored to co-host the Annual Couch-Stone Spring Symposium of the Society for the Study of Symbolic Interaction.

Opening keynote addresses were delivered by Gloria Ladson-Billings, past president of the American Educational Research Association and Ian Stronach, past editor of the British Educational Research Journal. The theme of the Fourth International Congress, "Ethics, Evidence and Social Justice," built on and extended the themes of the first three Congresses which focused on "Qualitative Inquiry in a Time of Global Uncertainty," "Ethics, Politics and Human Subject Research in the New Millennium," and "Qualitative Inquiry and the Politics of Evidence." The 2008 Congress offered scholars the opportunity to engage in debate on ethical, epistemological, methodological and social justice issues.

The politics of evidence and ethics carry important implications for how qualitative research is used in the pursuit of social justice. Delegates explored the relationship between these three terms, while studying new ways of evaluating and using qualitative evidence in social policy arenas.

The International Association of Qualitative Inquiry (IAQI) was launched in 2005 at the

First Congress. Four years later this new association has a Newsletter, over 1500 members, its own international journal--the International Review of Qualitative Research, a book series with Left Coast Press, an annual "Outstanding Qualitative Research Dissertation Award, and collaborative relationships with more than 55 international qualitative research centers.

The theme of the Fifth International Congress of Qualitative Inquiry (May 20-23) is "Advancing Human Rights Through Qualitative Inquiry." This theme builds on recent human rights initiatives taken by the American Association for the Advancement of Science, the American Education Research Association, previous Congresses, as well as the American Anthropological Association, the American Psychological Association, The American Nurses Association, the Center for Indigenous World Studies, Scholars at Risk, and the Society for Applied Anthropology In these troubling political times qualitative researchers are called upon to become human rights advocates, to honor the sanctity of life, and the core values of privacy, justice, freedom, freedom from fear, peace, and human dignity.

ICQI is very pleased to announce its two featured keynote speakers. Professor, author and human rights activist Antjie Krog will present a paper entitled "... if it means he gets his humanity back...': The worldview underpining the South African Truth and Reconciliation Commission." Award winning author and scholar Frederick Erickson will present a paper entitled "Human Dignity in Qualitative Research: Walking the Walk." IAQI: Community of Solidarities, Community of Hope, Ma. del Consuelo Chapela

A move towards empowering and emancipating qualitative inquiries is today endangered from several sides. Externally, there are the [US] federal government demands for evidence-based practice, where experimental and quantified knowledge becomes the privileged form of scientific evidence, and there is the ethical bureaucracy of the [US] Internal Review of Boards. Internally, qualitative research may involve an ethical subjectivism, disregarding the manipulative potentials within qualitative research processes, as well as the application of qualitatively produced knowledge as evidence bases for management and marketing practices of an experiential economy (Kvale, 2008:5).

Qualitative researchers belong to a global community. The recent Scientific Based Research disputes and conflicts in the United States are also being felt in Europe, Australia, South America, Africa, and elsewhere. The interpretive community needs to draw together into one large community so we can share our problems and experiences with these new discourses... We need a community that honors and celebrates paradigm, and methodological diversity, and showcases scholarship from around the world (Denzin, 2008).

Since 2005, in IAQI we are building up a hope. We are looking for human ways to address academic responsibilities with this old-mate, our old, old, mistreated, world. We look for what is not there, what must be done, yet, we know some others are strong in keeping the gates of unquestionable truth, gates that even when we don't intent to cross, tremble with our distant song, with the light of our always moving understanding, with the hurricane of our will of

social justice, equity and compassion. We look for phoenix tears to do the miracle of human history: bring alive this world all over again.

The International Association of Qualitative Inquiry (IAQI) is nothing else but us, a community of scholars who think qualitative inquiry has change potential; who think equity is possible and can be achieved within scholars of all races, disciplines, histories, situations, living lives; who find in our academic crafting a way to social change, therefore looking for quality academic discussion, political companionship, and strength; who come and go conforming and vanishing, as the many voices we are meant to recover get closer and clearer, or farther and blurred.

IAQI is a community struggling in the field of science politics. We aim change when inquiring into problems of under-empowered, relative to hegemonic power, groups in society; in a way that, increasingly more, makes hegemonic science look at its limited capacity to human understanding; providing more and more understanding about 'human benefit' fallacies constructed in the name of positivistic hegemonic science. IAQI is by no means politically neutral. Many IAQI affiliates have struggled alone with institutional policies, lack of support, and incomprehension. IAQI is a community to look at to stop fighting alone, developing political strength by pooling collective political and academic efforts.

IAQI recognizes the need of collaboration between paradigms, of developing our own quality standards, intense communication between qualitative researchers of all parts of the world, and to encourage qualitative inquirers to look into reality problems that are relevant to social justice and a humanizing ethics. IAQI also recognizes gaps and inequity between scholars' conditions to produce and communicate high quality research and how that hinder the impact capacity of ideas and understandings developed in contexts of scarce resources, upon national and international QI advances and research policies.

QI socialization for new young scholars is also principal problem to IAQI, as much as it is the problem of self- critique and self- learning of many researchers recently discovering QI. Whilst promoting high quality QI, IAQI needs to be alert about the understanding and uses of QI as fashion, resulting in micro-wave cooked scholars, researches and communications.

Since 2005 IAQI has developed strong, yet, we need more affiliates' participation; a goal for IAQI this year is to strengthen associates' awareness about IAQI, participation possibilities, and communication between IAQI community members. The achievement of this goal is also a way to rely in IAQI affiliates to make this organisation more visible outside IAQI.

The incorporation to IAQI of a large amount of members coming from non-anglo academic communities has raised the problem of equity among QI researchers which in turn leads to lack of inclusion in QI advance of valuable QI knowledge and understanding. A second goal for IAQI is to find ways to more equal voice presence in QI academic discussion.

IAQI looks for discussion and training to improve quality; searches for inclusiveness and QI development in different parts of the globe. IAQI strength is in the line of passion, compassion, intelligence, strive for a better world, development of high quality academic profile, will for equity, dialogue, generosity, hope. Presently, these are IAQI main resources and we can make magic by transforming our main resources into materialities. A third goal this year is to identify and pool members' needs and resources.

As IAQI becomes stronger, we need to organize in a way that can ensure IAQI objectives of openness, horizontality, inclusiveness, and accessibility. A fourth goal this year is to discuss, clarify and continue making understandable, efficient, and practical, present ideas of sites, nodes, and communities of meaning.

A DAY IN TURKISH (ADIT) QI2008

"A Day in Turkish 2008" (ADIT2008), a QI2008 conference language event, was held at the University of Illinois at Urbana-Champaign in May 17th, 2008. ADIT2008 aimed to open up a discussion platform for the development, exchange and critique of ideas on issues and trends of education research, particularly qualitative research, in Turkey. Seventeen papers were presented in 4 panel sessions of ADIT. After receiving positive feedback from the academic and educational circles in Turkey about ADIT-2008, the Turkish Educational Research Association declared to be the major sponsor for ADIT-2009.

For the future, we wish to further foster an international and cross-cultural dialogue and participation to ADIT-2009, encouraging exchange of information among academicians from different countries and nationalities. ICQI 2008: In Review

A Day in Technology in Qualitative Research: 2008

The 2008 Congress of Qualitative Inquiry made history with the advent of the "A Day in Technology in Qualitative Research" a pre-conference day devoted to discussion of the role of technology in our work. The full-day experience was kicked off with a welcome from Norman Denzin, followed by keynote presenter, Mei-Po Kwan of the University of Ohio. Professor Kwan's talk, "Geo-Narrative: Extending Geographic Information Systems for Narrative Analysis in Qualitative Research" challenged the audience to consider emerging perspectives on technology, setting a bold tone for the day. Comments on Kwan's presentation included "I can see the application to community development." "Wonderful, provocative, energizing."

A Technology Showcase provided participants with tasters of several brands of qualitative data analysis software: Hyper Research, MaxQDA, NVivo, QDA Miner, Transana, and X-Sight. A panel of software developers discussed issues in the development and application of this important tool within the field of qualitative research.

The afternoon was devoted to paper sessions that spanned the gamut from discussion of working within digital communities, and the wider contextual issues related to adopting new technologies to philosophical perspectives and the teaching of qualitative data analysis software.

Participants, who ranged from university faculty and doctoral students to independent consultants and software developers, came together at the end of the day to assess the issues that had been raised. All seemed pleased to have had an opportunity to discuss the subject in depth, and many expressed approval that the notion of technology had encompassed more than simply the use of qualitative data analysis software. For the upcoming year, the planning group is reviewing the best way to continue the technology strand within the Congress.

A DAY IN SPANISH (ADIS08): QI2008

This year, ADIS08 was organized by Fernando Peñaranda, Gloria Molina, and a group of researchers from the University of Antioquia, Colombia. The University of Antioquia also sponsored this event. ADIS08 took part on May 14th with an attendance of 117 scholars working in parallel sessions. We also held three conversatorios, where ADISP08 participants had the opportunity to dialogue about the main QI08 topics: ethics, social justice and evidence.

During ADIS08 we recognised how the International Congress of Qualitative Inquiry has become relevant to our Spanish speaking community since it has strengthen our qualitative voices in academic spaces dominated by positivistic paradigms. We also recognized the importance to raise our voices since we have knowledge to share with the academic qualitative community around the world, sometimes invisible because of language barriers. We found particularly important that during ADIS08 many non-Spanish academic speakers showed interest in the topics we were discussing from our Ibero and Latin-American perspectives. There are many qualitative initiatives such as decolonising, white, feminist or other methodologies, in need to listen and learn from the Spanish speaking community at the time that the Spanish speakers have much to learn once inbuilt- in- language colonization meanings are eradicated. ADIS08 facilitated to share and discuss about experiences, understanding, knowledge, and problems among the Spanish speakers community, to pinpoint some common problems, to discuss about initiatives, and also helped participants to join QI08 in a more active and participatory way.

Resulting from ADIS08 success and the Portuguese participants' enthusiasm expressed since ADIS07, we moved forward into the incorporation of the Portuguese community therefore turning into ADISP09 (A day in Spanish and Portuguese) for next QI09. Also during ADIS08 a structure of 'nodes' emerged for ADISP09 organisation which will benefit from the generation of collaborating 'nodes' in Argentina, Brazil, Colombia, México, Spain, Perú, USA (Urbana, Illinois), and Venezuela. The organization of ADISP09 will be in charge of Malu Bosi, Universidade Federal do Ceará, Fortaleza, Brazil and Sergio Rezende de Carvalho, Nelson Filice, and Rosana Onocko Universidad UNICAMP, Campinas, Brazil. The former ADIS organisers (México, ADIS07 and Colombia, ADIS08) will advice and support the work of the node in Brazil.

During ADISP09 we are programming different activities that may help in the better achievement of ADISP and QI objectives. Alerts about ADISP09 programme and ways in which you can participate will appear in the official QI09 web page.

CFP: "Qualitative Research in Communication," Special Issue of SCJ

Deadline For Submission: October 15, 2008. Guest Editor: Kenneth N. Cissna

The Southern Communication Journal is pleased to announce a call for a special issue (or perhaps two) devoted to qualitative research in communication, which seeks to provide an outlet for exemplary qualitative research on a wide range of communication topics. All qualitative approaches are welcome. Submissions must be data-based in some way, rather than primarily reviews of literature, calls for research, or conceptual essays.

Manuscripts generally should not exceed 30 pages, including text, references, notes, tables, and figures, and must conform to the APA (5th ed.) and include an abstract of 100-150 words, Times New Roman font, and double-spaced throughout with one inch margins and 12 point font. They should be free of sexist and discriminatory language, and of author-identifying references.

Submit manuscripts through the Manuscript Central website for SCJ (http://mc.manuscriptcentral.com/rscj). Authors must indicate that the submission is for a special issue in order to have the manuscript routed correctly, and include (a) a title, (b) names and affiliations of all authors, as well as contact information for the corresponding author, and (c) a word count. Submissions must include (a) a history of the work (including a description of any presentation or publication of any of the data or portions of the manuscript, and whether the manuscript arose from a thesis or dissertation), and (b) a statement that the manuscript is the original work of the author(s), and not under review nor published elsewhere.

Upon notification of acceptance of a manuscript, the author must provide a copy of the completed manuscript as well as an electronic copy of any artwork and figures (in EPS, TIFF, or PSD format only: 300 dbi or higher), and must assign copyright to the Southern States Communication Association.
